TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLES

Directorate of Health Safety & Regulation, HP Shimla intends to dispose of condemned vehicle No. HP03A-2392 as is where is basis.

2. Interested Parties may submit their highest prices for vehicle in a sealed cover latest by 2.00PM on or before 22/10/2018. The inner cover containing quotations and other relevant documents alongwith Demand Draft towards EMD should be sealed properly. Sealed quotations may be submitted in the office of Director Health Safety & Regulation, Red Cross Building, Near Governor House, Chhota Shimla. Both the inner and the outer covers should be superscribed in bold Capital letters "QUOTATIONS FOR DISPOSAL OF VEHICLE HP-03A-2392".
3. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this Department. The condition of the vehicle can be inspected physically between 8/10/2018 to 18.10.2018 at State Health and Family Welfare Training Centre, Parimahal, Kasumpti Shimla-9.
4. The quotation should be accompanied by earnest money for Rs. 10,000/- in the form of Bank Draft in favour of Director Health Safety & Regulation, HP, Shimla. The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest bidder/successful bidder fails to deposit the sale price within week's time positively, his earnest money will be forfeited. In case the offer is withdrawn by any bidder, the earnest money deposited by him shall also be forfeited.
5. The successful bidder will be required to deposit the total bid amount by means of Demand Draft in favour of Director Health Safety & Regulation, HP, Shimla within three working days of award of the contract.
6. Earnest Money Deposit (EMD) of the successful bidder(s) will be released only after realization of Sale proceed amount. EMD of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD amount will be adjusted in the Sale Amount.
7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card/Aadhar Card in case of individual and Registration Certificate in case of firms etc.)
8. The sold vehicle will be removed by the successful bidder(s) within 48 hours of depositing the money at their own expenses. No assistance/transportation will be provided by the Department. Permission to take out the disposed vehicles from the aforesaid premises will not be allowed on Govt. holiday and Sunday.
9. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
10. The Director Health Safety & Regulation, HP Shimla reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
11. EMD of unsuccessful bidder shall be returned within three weeks of auction of vehicle to the successful party.



12. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.
13. Disputes, if any, shall be subject to jurisdiction in the Court of Shimla only.
14. If the highest quoting firm fails to honour the bid; the bid will be cancelled & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible bidder (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party. In case of any dispute, decision of Director Health Safety & Regulation, HP Shimla shall be final.
15. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotation(s) not signed by authorized signatory shall be rejected.
17. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
