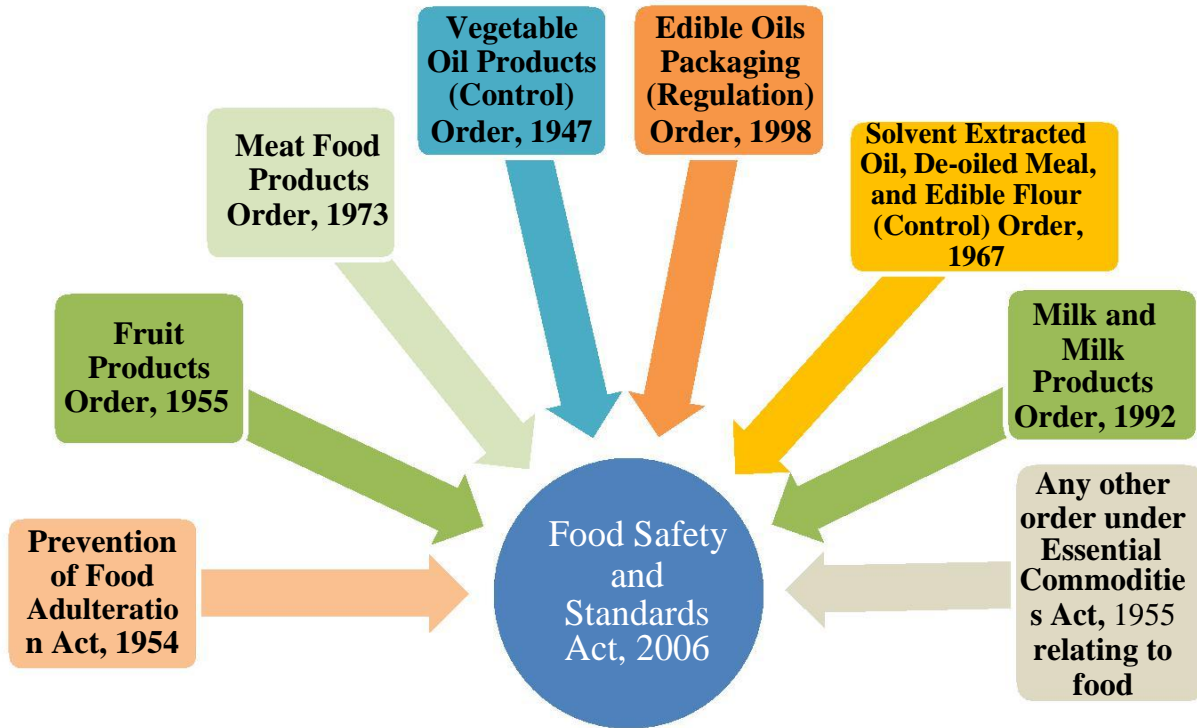
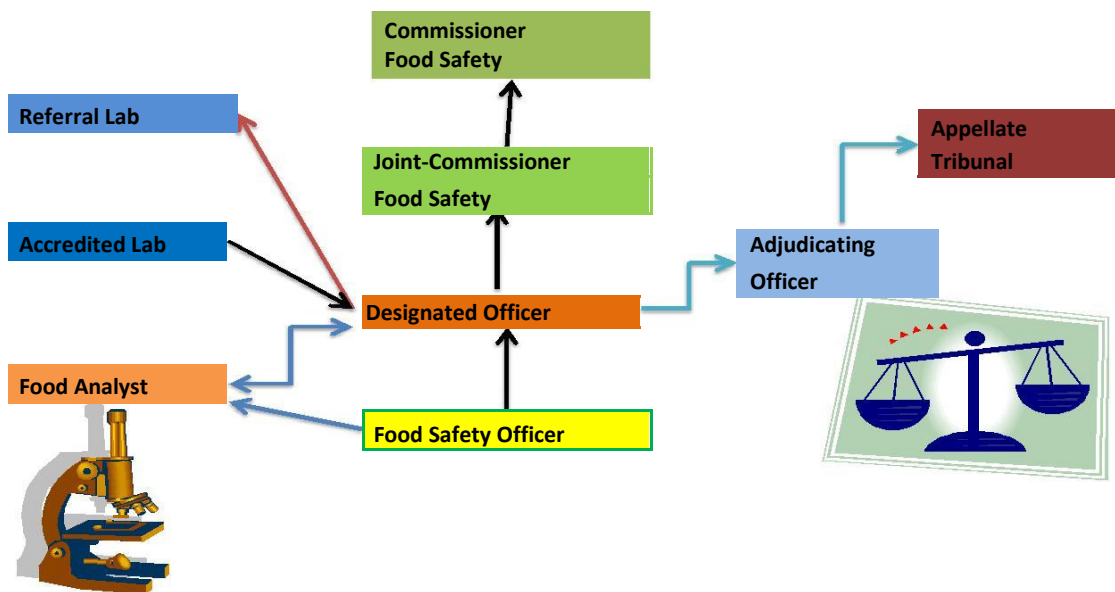


# Food Safety & Standard Act, 2006



**Date of Implementation of Food Safety & Standards Act, 2006 : 5.08.2011**

## Regulatory Enforcement in the State of H.P.



- ▶ Principal Secretary (Health) notified as **Food safety Commissioner** under Section 30 of the FSS Act, 2006.
- ▶ Director Health Safety & Regulation notified as **Joint Commissioner Food Safety**.
- ▶ Two Deputy Commissioners and ten **Additional District Magistrates notified as Adjudicating Officers**.
- ▶ Food Safety **Appellate Tribunals** Constituted under Section 70 of the FSSA, 2006 - all the **District & Session Judges notified as Presiding Officer** of the Tribunals.
- ▶ Senior Scientist, Composite Testing Laboratory, Kandaghat, Distt. Solan has been notified as Food Analyst for the State of H.P.
- ▶ At present there are twelve Designated Officers (Food Safety) working in the State of H.P.
- ▶ At present there are two Food Safety Officers working in the State of H.P.
- ▶ Online FLRS (Food License & Registration System) launched in the state on 8.5.2013 and the Commissioner of Food Safety has notified all the Designated Officers (Food Safety) as Registration/ Licensing Authority in the State.
- ▶ All Designated Officers empowered under Section 69 of the Act to compound offences upto Rs. 1.0 Lakh
- ▶ **State and District Level Steering Committees** have been constituted.
- ▶ Government Notification No. Health-A-h(1)-1/2013-Loose-II dated 19-12-2017 **prohibits** the products marketed separately to constitute Gutka or Pan Masala, Scented/Chewing Pan Masala or Tobacco, Supari, Khaini, Masherri, Zarda etc. for the period of **One year** from the date of publication of this notification.

- ▶ The State of Himachal Pradesh has received **two Mobile Food Testing** Laboratories on 17th October, 2017.
