NOITCE FOR 2nd ROUND GNM TRAINING COUNSELLING -2022

In continuation to this Directorate Notice dated 21.11.2022 vide which the 2nd round of counseling for admission to unfilled vacant seats scheduled on 22.11.2022 was postponed due to administrative reasons, has now been fixed on **28.11.2022** in the Auditorium Hall, IGMC, Shimla. It may noted that only those candidates will be considered for allotment of seats in Government GNM Schools who have already appeared in 1st round of counselling held on w.e.f. 17.10.2022 to 20.10.2022.

The criteria for selection to the above said course is purely on the merit of candidate in the 10+2 (qualifying examination). The first preference shall be given to candidates of 10+2 (Medical Stream) and in the eventuality of non availability of eligible candidates of medical stream, the second preference shall be given to the candidates of 10+2 (Non-Medical Stream) and lastly to the 10+2 (Arts and commerce stream) in order of merit. However, the actual number of private nursing schools and seats may vary upto the date of counselling. The details of counseling process are under:-

GNM Schools in the State of H.P, the institution wise and category wise details are as under and candidates will be offered choice of institution in their respective categories/sub-categories in order of merit. The number of Government available seats may increase or decrease in the Government GNM training Institutions.

All the eligible applicants are informed to be present for the Counselling on the scheduled date, time and venue along with all the original documents viz. Matriculation, 10+2, Character Certificate issued by the Tehsildar, Bonafide Certificate, SC/ST/OBC and IRDP/EWS (Economically Weaker Section issued by the concerned SDM as per Annexure-A/Tehsildar /Wards/Widows of Defence Personnel/Ex-Servicemen/ (duly signed by the Deputy Director, Sainik Welfare, Deptt.)/PHY.HANDICAPPED/WARD OF F.F ETC. Certificates and also bring photocopy of each certificate duly self attested .Further, for any clarification the candidates may enquire from the office of Director, Medical Education & Research, SDA Complex Block No-18B, Kasumpti at the office Telephone No. 0177-2624895 & 0177-2620733. The details of counselling schedule are also available on the departmental Website www.hp.gov.in/hpdmer.

It may also be noted that waitlisted candidates who had appeared in 1st round of counselling held w.e.f 17.10.2022 to 20.10.2022 will be considered for allotment of GNM seats in order of merit-cum-choice of institutions depending upon the availability of seats. However, the presence of these candidates is mandatory in 2nd round of counselling. Besides, the candidates who have already been allotted institution during 1st round of counselling and are interested for shifting of their institutions also need to appear in the counselling scheduled to be held on 28.11.2022.

The list of Government and Private Nursing Institutions shall be displayed at the venue of counseling.

NOTE: (i) ALL THE APPLICANTS ARE INFORMED THAT ONLY THOSE CANDIDATES WHO HAVE ALREADY APPLIED AND FALL IN MERIT AS MENTIONED AGAINST EACH CATEGORY ABOVE WILL BE CONSIDERED FOR THE 2nd ROUND OF COUNSELLING PERCENTAGE-WISE/CATEGORY-WISE ON THE PRESCRIBED SCHEDULE DATE, TIME AND PLACE. NO CALL LETTER/INTIMATION WILL BE SENT SEPRATELY BY POST.
